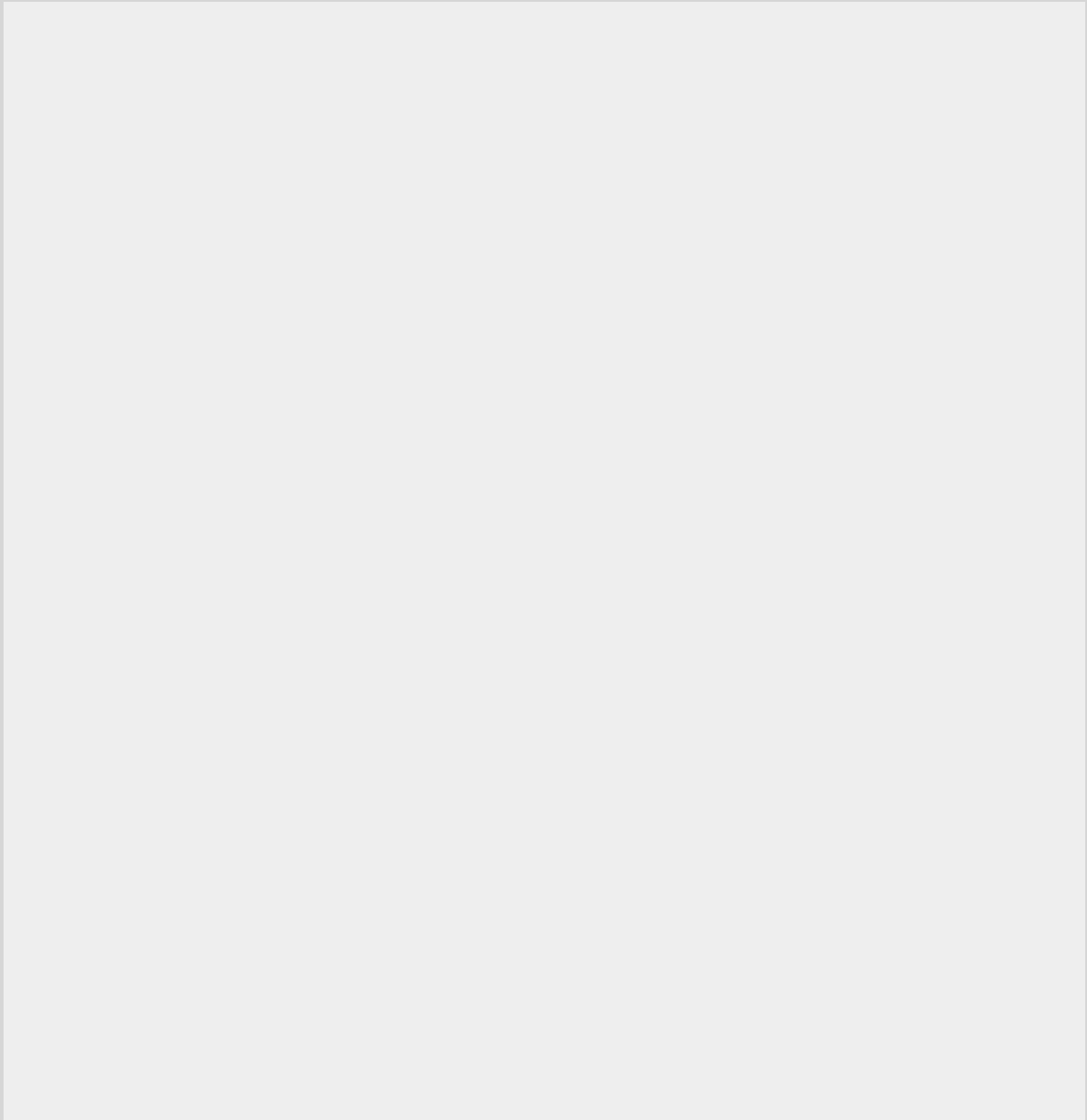

What is the current state of the Danish environment? The report "The State of the Environment in Denmark, 2001" attempts to answer this question.

The report summarizes the existing knowledge of some of the central trends in the state of the Danish environment. In addition, it describes the development in some of the sectors of society that contribute most to the pressure on the environment, as well as the relationship between the environmental trends and societal development.

The report is divided into five chapters. The first deals with societal pressures. The next three chapters concern the three media: Air, water and the terrestrial environment, and the last chapter deals with the urban environment and man. Apart from the broad description of the topics, each chapter contains selected theme sections that provide a more detailed examination of a number of issues of current interest.

The report is the third Danish State of the Environment report, and has been prepared by the National Environmental Research Institute in close collaboration with other parts of the Ministry of the Environment. The previous reports were published in 1993 and 1997.
